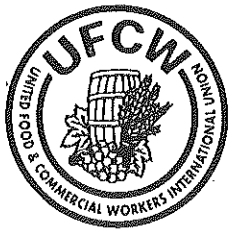

NOTICE OF RUNOFF ELECTION FOR THE OFFICE OF PRESIDENT

Pursuant to:

ARTICLE XII, SECTION K of the Constitution and By-Laws of Local 186D, "A plurality of votes cast shall be required for election except as to the offices of Local Union President and Secretary-Treasurer, where a majority of votes cast shall be required for election. Where the election for an office other than President or Secretary-Treasurer, results in a tie or where no nominee for Local Union President or Secretary-Treasurer receives a majority of votes cast, a runoff election between the two nominees with the higher number of votes shall be conducted."

Based on the foregoing, as required there will be a runoff for the office of President between the following:

Ballots will be mailed by the California Elections Company on **Friday, November 19, 2021** and must be received in the mail by the California Elections Company no later than **12:00 noon Monday, December 20, 2021** in order to be counted. **The ballot tally will take place at the UFCW LOCAL 186D, 329 Downey Ave., Modesto, CA 95354 on Monday, December 20, 2021 at 12:00 noon.**

For the purposes of this election a member eligible to receive a ballot to vote will mean that the member must have been eligible to vote in the prior election held **November 12, 2021**. There will be no additions or deletions from that eligibility list.

Duplicate ballot requests should be made **personally** to the Union Office at **1-209-524-4245**. The requester must provide his/her full name, address, telephone number, Social Security number, name of employer and the reason for needing a duplicate ballot. Written requests should be addressed to Rhonda Silva, UFCW LOCAL 186D, 329 Downey Avenue, Modesto, CA 95354. The Union office does not have ballots, only the California Elections Company will mail ballots.

No request for a duplicate ballot, either by telephone or in writing should be directed to anyone else as indicated above.
